Position Summary

We are seeking passionate and dedicated Community Health Workers (CHWs) to serve as liaisons between **The Caraway Foundation** and the community. This role is part of a study focused on addressing food inequity under the oversight of "**Healthy Living Anson**". CHWs will play a critical role in improving health outcomes by providing education, support, and resources to study participants.

***This is a time-limited contractor position and is based on grant funding renewal.**

This position is ideal for individuals with strong ties to the community, a passion for humanitarian efforts, and a commitment to reducing health disparities.

Key Responsibilities

1. Community Outreach and Engagement

- Build trusting relationships with study participants to promote health and wellness.
- Provide ongoing encouragement and support to participants.
- Deliver Med-South Lifestyle Program (MSLP) counseling to participants.
- Conduct biometric measurements as needed.

2. Health Education and Advocacy

- Provide culturally relevant health education on topics like nutrition and chronic disease prevention.
- Advocate for individuals to access essential services and health resources.
- Identify and help participants address barriers to care, such as transportation, language, or financial issues.

3. Support and Case Management

- Assist participants with questions regarding the study, enrollment, consent, and surveys that will be required.
- Assist participants with setting health goals, creating actionable plans, and connecting participants with local healthcare providers and community resources.
- Monitor and record progress throughout the study (beginning, midpoint, and end).
- Participate will require various ongoing trainings as apart of the training requirements. All trainings required provided by TCF at no cost to the CHW.
- Use hospital reporting data to identify potential participants and facilitate enrollment.

4. Data Collection and Reporting

- Maintain accurate and detailed records of client interactions, biometrics, and services provided.
- Collect and report data to assess program effectiveness and outcomes.

5. Collaboration and Communication

- Collaborate with project partners, including the Anson County Health Department, Atrium Health (Anson), and community organizations.
- Communicate participant needs and feedback to the Project Director.

Qualifications

Required:

- High school diploma or equivalent.
- Strong ties to the local community (preferred) and an understanding of its needs.
- Excellent communication and interpersonal skills.
- Ability to work independently and collaboratively as part of a team.
- Basic computer proficiency for documentation and reporting.

Preferred:

- Certification as a Community Health Worker (or willingness to obtain certification).
- Experience in community health, social work, or related fields.
- Bilingual or multilingual skills.

Working Conditions

- Seasonal employment for 8 months per year, with part-time hours.
- Travel within the community may be required; reliable transportation is necessary.
- A centralized location will be provided for administrative tasks such as making counseling calls and taking incoming calls.

Compensation and Benefits

- \$20 per hour.
- Hired as a contract employee—no benefit package offered.
